This spring a company will be coming in to paint the parking lines on main st & double yellow lines down the business district. Well #2 needs pulled, for repairs will be contacting Thien Well for this summer. We are waiting on Midwest coating for contract for redoing previous work done before sending payment.

Police Chief Corrinna Wagner gave a copy of the police report.

Superintendent Daniel Hoey came before the council to discuss yield signs and crosswalks near the school; we will be exploring options.
