ORDINANCE No. 2026-0817

AN ORDINANCE AMENDING TRIPP CITY ORDINANCE, TITLE 3, CHAPTER 3.01, SECTION 3.0102, (TO ADD A NEW SUBSECTION: 3.0102(J)):

BE IT ORDAINED BY THE CITY OF TRIPP, SOUTH DAKOTA, THAT TITLE 3, CHAPTER 3.01, SECTION 3.0102 (ACTS, OMISSIONS AND CONDITIONS PROHIBITED) – BE AMENDED, BY ADDING A NEW SUBSECTION (J), WHICH READS AS FOLLOWS:

3.0102 “(J) RIGHT OF ENTRY.

When it is necessary to make an inspection to enforce the provisions of this chapter, or when the City Council, or its representative, has reasonable cause to believe that there exists upon a premises, a condition that constitutes a nuisance or otherwise violates the provisions of this chapter, in such a manner that makes the premises unsafe, dangerous, dilapidated, or hazardous, the City’s representative may enter the premises (and any buildings/structures located thereon) at reasonable times, to inspect or to otherwise perform the duties imposed by this Code. If any building or premises be occupied, then the City’s representative shall present his/her credentials to the occupant prior to entering. If any building or premises be unoccupied, the City’s representative shall, prior to entering, make a reasonable effort to locate the owner or other person having charge or control of the premises, and give notice of his/her intent to enter and inspect. If entry is refused, the City’s representative shall have recourse by virtue of any remedy provided for by law, including (but not limited to) an application for inspection warrant, to be issued by a Court of competent jurisdiction.”

the Municipal Ordinances of the City of Tripp, South Dakota, is hereby enacted as follows:

5.0801 Intoxication.

liquor in any private house or place to the annoyance of any person.~~ No person
shall be or remain in a state of intoxication, drunkenness, or under the influence of
intoxicating liquor in any public place.
