a. Who will be served by this project?

The Tripp Community Pool serves the City of Tripp (population 647) and the surrounding area, benefiting primarily the youth of the community, who make up the majority of the pool users. In addition to residents, the pool attracts visitors from nearby towns such as Menno, Scotland, Kaylor, Delmont, Armour, Parkston, and the Avon area. These visitors often take advantage of the private lessons offered at the pool, with over 100 individuals participating in the program. Even this spring, people from neighboring towns have been calling to inquire about the summer lessons at the Tripp Community Pool.

The pool is a vital resource for the youth in the area, offering both recreational and educational opportunities. School-age children use the facility for swimming lessons and leisure, while the pool also provides valuable summer employment for local teenagers and adults. The fees are affordable, making it an accessible family activity: day passes cost \$5.00 or less, and a family season pass is only \$60. Last summer, the pool sold over 30 family passes and welcomed more than 25 children daily to the pool for open swim.

Located just across the street from the Tripp ballfields, the pool area is a central hub for youth recreation during the warmer months. There are also public camping spots nearby, available for just \$10.00 per night. These spots offer a convenient way for visitors to enjoy the park's amenities, as well as a gathering place for the local community at Klatt Park. Additionally, the park and pool are situated across the street from the Hutchinson County Fairgrounds, where the county's three-day fair takes place each July. Visitors to these local attractions are also potential patrons of the Tripp Community Pool.

Analysis of need for the completion of this project

The 2023 SD SCORP mentions that swimming pools in South Dakota are aging and deteriorating due to time and harsh weather conditions. This is the case with Tripp's 57-year-old pool. Generations of Tripp residents have spent their summers enjoying the facility and finding relief during hot South Dakota summer days; however, its age and condition are a major community concern. They want to ensure that the pool will be functional for future generations, but major updates and repairs are necessary to make that possible.

The City of Tripp applied for an LWCF grant 13 years ago, but they were not awarded. Since then, the city has done their best to keep up with maintenance and pool needs. However,

the costs and needs continue to grow. As the years go on, and with continued use, the costs and needs associated with the facility will only continue to increase if some major repairs and updates are not completed soon.

This spring, the city asked Over Built Construction out of Sioux Falls to evaluate the facility and offer an estimate on repairs needed. The necessary updates are as follows:

- Replace the pool deck and add new ladder cups
- Conduct plumbing repairs
- Replace pool skimmers and sand filters
- Install new diving board
- Remove, sandblast, chip, and repaint the pool
- Demolish and replace the top of the pool wall
- Remove the old fence and install a new fence
- Add wading pool skimmers and new water fountain

b. Goals and objectives to be met

The City of Tripp's goal is to provide a safe and efficient pool facility for its community and the surrounding area. Without the repairs and renovations included in this project, the viability of a community pool in Tripp is in jeopardy.

In recent years, the City of Tripp paid for improvements to the pool deck, but the repairs failed. Concrete sections on the pool wall are separating and moving separately, which has created cracks and allowed sand to enter the pool. This is putting extra stress on the skimmers and creating concern that the cracks will only get worse with time unless repairs are done soon.

All the repairs listed in this project would make the facility safer, conserve water, and lower operational costs. Current leaking issues are leaking unknown amounts of water and increasing the amount of water the city needs to supply to keep the pool at capacity.

c. Describe the proposed action and alternatives

The repairs needed for the community pool have been under discussion for many years. However, funds and other community needs have been obstacles. The city and its leadership are now ready to make the pool a priority and ensure that the facility is safe, efficient, and welcoming for all visitors for years to come. These renovations and improvements are not just to improve the look or aesthetics of the facility. They are to improve the function of the facility and ensure safety for its users. The first goal is to replace the deck of the pool, which is severely cracked and threatens the integrity of the entire facility. In addition, plumbing repairs will be done to find, diagnose, and repair leaks in the system. These leaks make the facility inefficient and waste local water resources. Repairing the deck and fixing these leaks will be good not only for the community but also for water conservation.

The skimmers and sand filters also need to be replaced within the pool. Skimmers are an essential part of pool maintenance. They remove debris, such as leaves, twigs, and insects, from the surface of the pool by catching them in basket-like devices. The cleaned water is then returned to the pool through jets. When skimmers are not working properly, significant problems may arise, such as water loss, poor water quality due to increased debris, potential algae growth, increased stress on the pool pump, and potential damage to the overall filtration system.

Once the deck is complete, the top of the pool wall will be removed and replaced. This will include an 8-foot rebar the entire way around the pool that prevents expansion and movement, resulting in a longer life for the new skimmers.

Lastly, the diving board and ladder cups will be replaced before the pool has the old paint and chips removed and a new epoxy paint added. A new pool fence will replace the current fence for added security and safety, and the wading pool will be updated and a water fountain added.

The City of Tripp has been discussing the need for pool upgrades for quite some time. In 2012, the city applied for an LWCF grant for the pool, which was denied. Since then, the City of Tripp has worked to make small improvements. However, City leadership and residents feel the upgrades are now at a crucial point and need to be addressed to keep the pool operating safely and efficiently. Mayor Scott Schelske has discussed this project with

other communities in the area who have recently taken on a pool renovation project, doing their homework on contractors and potential obstacles.

ii. What information was made available to the public for review and comment? Did the sponsor provide written responses addressing the comments? If so, include responses.

The project has been discussed at recent city council meetings. The application was also uploaded to the City's website for people to review and provide comments (see screenshot below from Tripp's website).

e. Public comment periods and agency response – include how long the comment period was, when in the process was it completed, and who was invited to comment

The public comment period started when the LWCF application was discussed at the April council meeting. This period continued while the application was available on the city website on April 14. Comments were accepted from everyone.

f. When will the project be completed and open for public outdoor recreation use? Assume that successful applicants will have access to grant funds by spring 2026.

The city will be ready to begin the project immediately after notification of the award, ideally in the spring of 2026. The exact timing of the work activity will depend on the vendor's availability, but City staff will be available at a moment's notice to do any pre-work site prep that may be needed. They have already discussed and received approval from a local bank to borrow money for the local share of this project.

g. What strategies in the 2023 SCORP support your project? Explain how each strategy applies to your project

The 2023 SCORP provides ample justification for this project. The public survey demonstrated that outdoor activities and spaces are a great asset to a community like Tripp. According to Table 1-2 of the SCORP, swimming at a pool ranked third out of seven in frequency of water-based activities, behind motorized boating and swimming at a beach. Table 1-20 shows that swimming pools are one of the highest investment priorities for facility providers, behind only playgrounds and ballfields among over 20 types of facilities listed. In addition, public input indicated that maintaining existing parks and recreation areas, like the Klatt Park and Tripp Community Pool, was the second highest priority for projects and funding. Most facility providers, just like those in Tripp, have concerns over the limited resources available to invest in and maintain these facilities.

Strategy #1 –

Provide and promote year-end diverse outdoor recreation opportunities for South Dakotans of all ages, interests, economic status and ability.

The project also aligns with the recreation strategies outlined in Chapter 3 of the SCORP. Under Strategy #1, one of the first objectives is to fund the renovation and replacement of existing structures, such as pools – especially in small towns. One of the priorities ranked high for local and state LWCF projects pertinent to this strategy are projects that provide facilities and opportunities at affordable costs and encourage family-oriented recreation.

The Tripp pool offers family-friendly recreation for area residents at a low cost of just \$60 for a family summer pool pass. Pools are more than just a swimming facility for children. They provide an outdoor recreation experience for families of all ages. Most South Dakotans have fond memories of summer days at the pool with their family and friends, and the City of Tripp wants to make sure their residents get the opportunity to have these childhood memories as well.

Strategy #2 –

Maintain and improve existing park and recreation areas, open spaces and facilities for outdoor recreation opportunities.

Under Strategy #2, investing in aging infrastructure and public facilities that need maintenance to reach at least minimum standards is a priority. A high priority for LWCF is projects that maintain, improve, or update existing outdoor recreation facilities like swimming pools. This is especially true when other federal matching programs are not possible or feasible. Updating and maintaining this community pool facility allows the residents of Tripp to use the pool daily during warm months. Without this pool, residents would need to travel to neighboring towns. For those with working parents or in a low socioeconomic status, access to a pool may become difficult or non-existent.


The City of Tripp does not have access to other federal funds that can help with the resources needed to make this project happen. Being a small, rural community, they are working with limited resources and are working to maintain and increase the quality of life for their residents. The local match will be provided by a loan the city will take on, which shows how important this project is to the community. Without funding from LWCF, this facility will likely have delayed maintenance. Delayed maintenance could result in facility failure or increased water loss due to leakage, or ultimately, the closing of the facility due to safety and filtration concerns.











Cracked pool deck and skimmers that need to be replaced




